Mr. Decker explained that there are 3 properties that he owns and passed out survey maps to allow the Board to see what he is presenting. He went on that the one parcel is not being affected, there is a 169-acre lot and an 8-acre lot that the lot line change will incorporate. Chair explained that the Town Attorney is not at the meeting and can extend the pre-application meeting to the next or can have him review the minutes and render an opinion on if this needs a full site plan. Theresa Santiago asked if he would have vehicles there to part out like a junk yard, Mr. Mann answered no.
