Mr. Schock explained that the Town is selling Boehmler Park to the City of Port Jervis and during a survey it was found there were a few encroachments, one being a shed and the other a driveway. This will fix those encroachments and give a small piece to 3 Residents of the Town that border the property. It encompasses 186 acres, and the Town does not need to adhere to their own Zoning this is just being done a formality. John Nosek asked if all dwellings were existing, Mr. Schock answered yes, he added that the buyer has no problem with this change in the lot. Chair stated that this will then go to the Assessor's Office and Glen Plotsky for deeds.

Mr. Hens stated that the applicant is ok with a chain link fence and the new submission reflects that, he feels all comments have been addressed. NYSDOT cannot move forward without a SEQRA determination, but have stated they are good with the entrance, also a Draft NOI (Notice of Intent) has been done. Chairman acknowledged that the Town Attorney is not present and would like to defer any motions until Mr. Plotsky is back, there is still questions on the decommissioning bond and need an approval from Glen. Mr. Dalaeli stated that the bond will be the same as the last project. John Nosek asked if the draft NOI has been filed with the DEC, Mr. Hens replied yes. Mr. Nosek stated that a letter from the DEC and DOT that the draft NOI was good and entrance. The Board could make a SEQRA determination but need an approval from Glen Plotsky for the decommissioning bond. Maziar Dalaeli acknowledged that he understands that the Town Attorney is not present but there are NYSERDA incentives that will be lost if this is pushed to another meeting. Chair apologized but stated he would feel better with the Town Attorney at the meeting. Chair asked Mr. Bavoso if Glen Plotsky was working remotely, he answered yes. Chair stated that we can send Glen the minutes and he can advise the Board and the applicant can come back in 2 weeks. John Nosek told the applicant to send in a set of plans that show the fence on the site plan, get it in within the time frame and they would be put on the agenda for the next meeting. Chairman asked if there was a certain profile for the fence that was needed, John Nosek stated that it was a standard 6ft high chain link fence.
