#### LOCAL LAW No. 6 OF 2000 A LOCAL LAW ESTABLISHING A BOARD OF ETHICS FOR THE TOWN OF DEERPARK, ORANGE COUNTY, NEW YORK

## SECTION 1. LEGISLATIVE INTENT

By the adoption of this Local Law, the Town Board of the Town of Deerpark chooses to establish a Board of Ethics for the Town, pursuant to Section 808, Paragraph 3 of the General Municipal Law of the State of New York.

#### SECTION 2. DEFINITIONS

The words and phrases and definitions of words as used in the New York State Town Law shall be applied in the enforcement of this Local Law.

## SECTION 3. BOARD OF ETHICS

The Town Board of the Town of Deerpark hereby establishes a Board of Ethics for the Town of Deerpark. The Board of Ethics shall have all the powers and duties of and shall be governed by the same conditions as a County Board of Ethics set forth in Article 18 of the General Municipal Law of the State of New York, except that the Board of Ethics of the Town of Deerpark can act only with respect to the officers, employees and agents of the Town. The members of the Board of Ethics shall be appointed by the Town Board and will serve at the pleasure of the Town Board. The Board of Ethics shall consist of at least Three (3) members, a majority of whom shall not be otherwise be officers or employees of the Town of Deerpark. The Board of Ethics shall include at least One (1) member who is an elected or appointed municipal Officer or employee of the Town. This Local Law has been created and enacted in order to specifically supersede any prior organizations or local laws originally creating a Board of Ethics for the Town of Deerpark.

## SECTION 4. SAVINGS CLAUSE

If any clause, sentence, paragraph, section or part of the Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, nor invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, or part thereof directly involved in the controversy in which such judgment shall have been rendered.

### SECTION 5. EFFECTIVE DATE

This Local Law shall take effect Ten (10) days after publication, posting or immediately upon personal service as provided in Section 133 of the Town Law.
