RESOLUTION 2 of 2025

AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONEYS

AGREEMENT between the Town Superintendent of the Town of Deerpark, Orange County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

- 1. GENERAL REPAIRS. The sum of \$453,876.14 shall be set aside to be expended for primary work and general repairs upon 12.15 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.
- 2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of town highways:
 - (a) On the road commencing at Lakeview Dr, Old Road, Sweet Fern, Hillcrest, Birch and leading to the Oak Ridge Park development, a distance of 1.12 miles. there shall be expended not over the sum of \$10,770.89. Type: Chip Seal Width of traveled surface: 12'

(b) On the road commencing at Hoag Road/US Route 209 S and leading to Hoag Road/US Route 209 N, a distance of 0.81 miles. there shall be expended not over the sum of \$ 11,684.25. Type: Chip Seal/ Fog Seal Width of traveled surface: 18'

(c) On the road commencing at Port Orange Road/US Route 209 and leading to Port Orange Road/NY Route 211, a distance of 1.05 miles, there shall be expended not over the sum of \$ 15,145.54. Type: Chip Seal/ Fog Seal Width of traveled surface:18'

(d) On the road commencing at Rio Dam Road and leading to The Town of Lumberland town line, a distance of 1.09 miles, there shall be expended not over the sum of \$ 17,468.85. Type: Chip Seal/ Fog Seal Width of traveled surface: 20'

(e) On the road commencing at Parks Road/NY Route 42 and leading to the dead end, a distance of 0.18 miles, there shall be expended not over the sum of \$ 2,595.29. Type: Chip Seal/ Fog Seal Width of traveled surface: 18'

(f) On the road commencing at Wilson Road/NY Route 42 and leading to Wilson Road/NY Route 97, a distance of 3.38 miles, there shall be expended not over the sum of \$ 54,170.14. Type: Chip Seal/ Fog Seal Width of traveled surface: 20'

(g) On the road commencing at Old Forestburgh Road/NY Route 42 and leading to West Peenpack Trail, a distance of 0.98 miles, there shall be expended not over the sum of \$ 14,191.18. Type: Chip Seal/ Fog Seal Width of traveled surface:18'

(h) On the road commencing at Lybolt Drive. and leading to dead end, a distance of 0.35 miles, there shall be expended not over the sum of \$ 31,916.00. Type: PPST Width of traveled surface: 18'

Thickness: 1"

(i) On the road commencing at Space Drive-Marlec-Lorelle and leading to Lybolt Drive., a distance of 0.2 miles, there shall be expended not over the sum of \$ 18,328.00. Type: PPST Width of traveled surface: 18'

Thickness: 1"

(j) On the road commencing at Wood Road and leading to the dead end, a distance of 0.28 miles, there shall be expended not over the sum of \$ 26,070.00. Type: PPST Width of traveled surface: 18'

Thickness: 1"

(k)	On the road commencing at Boxbaum Road. and leading to seasonal road beginning, a distance of 0.44 miles, there shall be expended not over the sum of \$ 39,974.00. Type: PPST Width of traveled surface:18'

(I)	On the road commencing at Academy Ave/Main Street and leading to Boxbaum Road (seasonal), a distance of 2.11 miles, there shall be expended not over the sum of \$ 198,290.00. Type: PPST Width of traveled surface: 18'

(m)	On the road commencing at Cuddeback Road. and leading to the dead end, a distance of 0.16 miles, there shall be expended not over the sum of \$ 13,272.00. Type: PPST Width of traveled surface: 16'
