PLANNING BOARD MEETING October 27, 2021 continued -

DEERPARK VILLAGE – WILSON ROAD – DISCUSSION/EXTENSION – Demetris Colocassides-Applicant

Mr. Colocassides explained that he sent an email showing the progress that had been going on with the project, they have closed on the loan and signed an architect and will be signing an Engineer soon. They were asking for an extension to keep everything moving and to prepare a site plan, they feel they will be ready in about 12-13 possibly 14 months. He was asking for the maximum extension possible and from December 8, 2021 which was the expiration date of the current extension in place. Town Attorney stated that he could not find the email, Mr. Colocassides explained what was in the email. Town Attorney stated that there will have to be revisions in the site plan due to changes to State standards, Escrows are still in place, a new traffic study will be needed, Storm water has changed since original approval. Mr. Colocassides stated that an Engineer will be signed next week. Town Attorney continued that approval will be on the total project but it will be built in phases, the cost of road construction needs to be looked at again due to change in price of materials and the cost of bonding roads needs to be looked at too. He further stated that it will take that applicant a substantial period of time but as long as they keep coming back and showing progress, they can be given extensions in 6-month increments. This extension will be 6 months from December 8. Willard Schadt stated that they are showing good faith and didn't see a problem granting an extension.
