1074 ROUTE 209 – BATTERY STORAGE – PRE-APPLICATION – Andrew Cleary-Bed Rock Energy

Mr. Cleary stated that they were an Albany based company, this will be small scale solar under 5MW, the storage will be about 10,000 square feet of coverage, it is a clean energy source. This will shift power from off grid times to peak times and be cost saving. There are 2 options but it depends on what Utility company wants. Each container will have 6 forty-foot lithium batteries, all wires will be underground, it will be an unmanned facility, gated and fenced. This property is currently a scrap yard they will be cleaning up some of that. Lithium is an organic substance, it burns hot and will not be put out with water, the State has a safety code to regulate this and also training will be given to the local Emergency Services. He explained that it is the same technology in cell phones and Tesla vehicles. Rob Whitney asked what the containers would be sitting on, Mr. Cleary answered concrete pads with gravel underneath. Rob Whitney asked if there would be security cameras, Mr. Cleary replied that they can. Rob Whitney asked what safety there is in case of a fire, Mr. Cleary answered there are fire suppression systems in place. He added there is spacing between the containers about 8 feet. He further stated that training will be done with the Fire Departments and an emergency response plan will be done. Rob Whitney asked if lithium is organic and if there is a fire what would happen when it gets in the air, Mr. Cleary answered that it is non-toxic. Town Attorney stated that there is no zoning for this in the Zoning Ordinance. Theresa Santiago asked if there was any noise, Mr. Cleary answered No.

Chairman explained the escrow agreement, Escrow is \$1500 Town Attorney, \$3000 Town Engineer, agreement was signed by all parties. A copy was made and given to Town Attorney, Town Engineer, Applicant, and one will be given to the Escrow Manager.

ECKES – ACADEMY AVE & UPPERBROOK RD – LOT LINE CHANGE – James Dillin-Representative for Applicant

Mr. Dillin explained that he was representing Carol & Wilbur Eckes, they would like to reconfigure the lot and have all improvements on the same parcel as the existing home. The lot is currently 1.2 acres there is no plan to build it will just allow the lot to have all improvements with the home. Town Attorney acknowledged that this is pre-existing non-conforming and this will make it less non-conforming.

Mr. Dalaeli stated that this is residential solar on a container, Rob Whitney asked why on there, Mr. Dalaeli answered it is unique it improves costs, some people do not want to put it on their roof, it will be away from the home and it is portable. One will be on Mr. Honders' home and the other 2 will be on Maple Crest Dr on homes that are owned by IPP Solar. John Nosek questioned if the containers were pre-existing, Mr. Dalaeli answered no they will be a "shed" with solar on them connected to the house. Craig Wagner asked if it would be battery storage, Mr. Dalaeli replied very small. Town Attorney acknowledged that ground mount solar is allowed, it goes into the grid, there is no provision for residential battery storage or direct link to a home, it is not in the zoning. Mr. Dalaeli stated that the battery storage will be taken off the application. He added that the containers will not be visible. Chairman stated that these will be accessory uses, Town Attorney added they will be on the accessory use. Town Attorney asked if the Maple Crest applications were within 500ft of Route 209 and explained the GML-239 process.
