Mr. Dalaeli stated that they were there to get a conditional approval. Chair Wagner asked if they received Fusco Engineering comments, Mr. Dalaeli acknowledged that they received them this morning, and are asking for conditional approval, there was also a letter from Town Attorney Glen Plotsky with recommendations. Town Engineer went through his comments that a SEQRA determination needed to be done, all environmental issues have been addressed. Also, a letter from the DEC (Department of Environmental Conservation) and DOT (Department of Transportation) were needed along with a decommissioning bond prior to maps being signed. The action should be a negative declaration and a special permit is needed due to the disturbance being over 5 acres. Willard Schadt stated that also included in the Town Attorney's comments a PILOT is being negotiated. Chairman asked about the fence, Mr. Dalaeli acknowledged that new plans were submitted to show the fence around the arrays for safety, chain link as required by the town. Chairman asked what all conditions of an approval was, Town Engineer answered DOT permit for driveway, SPDES (State Pollutant Discharge Elimination System), decommissioning bond being agreed on, phasing for the SWPPP (Stormwater Pollution Prevention Plan) and a PILOT (Payment In Lieu Of Taxes) agreement. Mr. Dalaeli stated that there was a phasing plan submitted it was on page 8 of the plans, Town Engineer replied to send the plan again. Willard Schadt asked if a subdivision would be done, Mr. Dalaeli stated that it would be a hyphened tax parcel for Orange and Rockland, it cannot be sold separately. Town Engineer stated that a building permit would be needed and it will not be issued until the decommissioning bond was paid. Willard Schadt added that the approval would be conditioned on fees paid as well.
