#### Planning Board Minutes March 8, 2017

Mr. Fuller explained that there are 7 properties involved in this Amended Site Plan Review and these properties are located on Route 97 and Hook Rd. He continued by saying that over a decade ago there was an approval for the current business but there are new uses for a few lots and a need for an amended site plan, he further explained with an approved amended site plan that Mr. Sauschuck wishes to consolidate all the parcels to one large parcel. Chairman Vicaretti asked if the consolidation can be done before the site plan approval. Town Attorney stated that there are 4 parcels without violations that are being consolidated, but the other lots have violations so if the modified site plan is approved then he can consolidate all parcels. Chairman Vicaretti questioned if any of the parcels meet Route 97, Alfred Fusco III answered yes. Town Attorney added that a GML-239 would need to be done. Mr. Fuller then went through the comments from Fusco Engineering and stated that the new map will show the septic, also the hours of operation are on the current map, and he further said that there will be no issue with getting a survey map. Mr. Fuller asked being it is an amended site plan if a public hearing is required. Town Attorney replied that yes it will require a public hearing because the site plan is 11 years old and there is new use of the lots. Mr. Fuller added that the nature of the business has not changed, there is now Mulch and Rocks that were not on the original site plan but neither were the lots. Town Attorney stated that a public hearing is required and will be 30 days out because of the 239 Review and it will be third on the schedule due to the two other before this application.

#### **OTHER BUSINESS -**

Chairman Vicaretti thanked Fusco Engineering for the comments to help sum up the report received from the DEC regarding Big Pond Mine. Town Attorney acknowledged that Fusco Engineering drafted a 3 page letter on behalf of the Town to the DEC and they threw them down. Alfred Fusco III stated that the DEC took exception to the pig farm idea and went through the DEIS (Draft Environmental Impact Statement) with a fine tooth comb, he also stated that the report addressed a lot of the things the Town had questions about.

Dave Dean acknowledged that John Fuller is the Engineer for New Hope Farms and the next visit will be better.

Chairman Vicaretti stated that he received a certified letter from M & M Blasting on behalf of Lock & Roll; the storage place on Route 209 which said that if Orange and Rockland Utilities do blasting it will ruin the buildings. Alfred Fusco III stated that Orange and Rockland approached him about 2 weeks ago on the Town's Blasting Policy, but there is nothing in the Zoning. They would have to get a licensed New York State Engineer to get a pre-blast and a post blast survey and before blasting they would need to notify Town Clerk, Police Department, Fire Department and Building Department. Chairman asked what the difference between fracturing and blasting, Mr. Fusco explained that fracturing is a low impact, there is no financial benefits for either one and there is pros and cons to both, but the adjoining parcels do have a right to be concerned but the Town will make sure everyone is protected.
