Meeting was brought to order at 7:02 PM.

YORK DONG – ADDITION TO MUSIC STORE – 388 GALLEY HILL ROAD –

Mr. Dong stated this was an addition to the Tian Yin Music Store, he continued that he had made revisions from Fusco Engineering last comments. Chairman Vicaretti asked if the last time he was there was April 2017, Town Attorney answered no he was last there September of 2017. Mr. Fusco stated that there were new comments in regards to the new map, Chairman asked if the old comments were satisfied, Mr. Fusco answered for the most part, yes. Mr. Fusco then went through the new comments. He continued it mostly is going to be cleaning up the map, filling out the Long Form EAF (Environmental Assessment Form) and getting signoff from DEC (Department of Conservation) and SHPO (State Historical Preservation Office) for the next meeting, due to what came up on the DEC Mapper. Willard Schadt asked why it wasn't done before, Mr. Fusco answered that the first Music Store the building was already present on the property so there was no disturbance it was basically just a change of use. Chairman asked if the GML-239 had to be done, Town Attorney answered that the question is if The Town of Mount Hope is 500 feet from property line. He continued that the Secretary will get with the Assessor to determine the distance to the Town line. He then suggested that a motion could be made subject to what the determination is by the Assessor's Office.

Chairman Vicaretti asked is the easement information was received. Town Attorney went over what has happened with this application he stated that January 2015 the Planning Board gave a conditional approval contingent upon DOT approval. The original map had certain driveways on them, but this project is on 2 parcels. Since than Mr. Feasley has gotten a new Engineer and on the new map she took 2 entrances and exits and made one with a one way. After doing that the smaller parcel has to go through the larger one so an easement agreement was needed. Now there is an easement agreement for both parcels and it needs to be recorded with the County, he suggested that be part of the approval. He continued that the only difference he can see is the service road that is on the new map was not on the original map, which he stated in his opinion was a good idea. Mr. Fusco stated that is was a small change, all comply with Zoning, and there are no issues.

Town Attorney stated that they paved an area that was already being used, Willard Schadt acknowledged that they changed that configuration of the track, Town Attorney stated that he will meet with Alfred Fusco III and look at the maps and report back at the February Meeting.


