## A LOCAL LAW REPEALING CHAPTER 67 OF THE TOWN OF DEERPARK CODE AND DISSOLVING THE POLICE COMMISSION OF THE TOWN OF DEERPARK

Article 1. <u>Legislative Intent.</u> The Town of Deerpark intends to dissolve the Police Commission of the Town of Deerpark, Orange County, New York.

Article 2. <u>Statement of Authority</u>. Under Section 150(2) of the Town Law of the State of New York, the Town of Deerpark is empowered to create and dissolve a Police Commission for the Town after a Police Department has been established for the Town.

Article 3. Enactment. The Town of Deerpark hereby repeals Chapter 67 of the Town of Deerpark Code enacted on June 13, 1983 and amended by Local Law No. 1 of the year 1997, Local Law No. 5 of the year 2000, and Local Law No. 10 of the year 2000 which establishes a Police Commission for the Town.
