Communications

*Town Clerk Florence Santini* announced that as of March 15<sup>th</sup> there would be a burning ban until May 15<sup>th</sup> and asked all residents to please not burn during that time per the State of New York. There are flyers in the Town Clerk's office if anyone needs them.

*Supervisor Gary Spears* said the town is planning on doing the town clean up in the month of May, where the town residents come in to the Town Clerk's office for a permit to take one load of debris, that the town pays for. More announcements to come.

Department Head Reports

*Highway Superintendent Ed Hughson* reported on an update for the work they will be doing on the roads. They have a \$75,000 grant from the county (CDBG) for Shinhollow Road, which will help out paying for about half of that road and then they'll use general repairs out of their budget. The other roads they'll be doing are Lime Kiln Road, Greenville Turnpike, Skinners Lane (which has a few roads inside it), and Brandt Road. Those five roads are over 7 miles of road that will be resurfaced this year. They are happy with the process they have used and will continue with the seal and tar and chip on top. The roads are holding up really well. They had an accident during one of the recent storms involving a truck rolling on its side and an injured worker. The worker's injury involved a concussion and he is still out. He should be back the 18<sup>th</sup> of March. The truck prices are being estimated and it will probably be totaled. He then announced the retirement of John Decker planned for March 30<sup>th</sup>, just two months shy of 34 years with the town Highway Department.

Old Business

General Code Discussion – *Florence Santini* mentioned the General Code and said there are two books of Local Laws in her office. She needs paper copies. She also has books of Resolutions in her office also. In 2004, the General Code took all her

paper copies and put them on a CD for anyone to see where the changes were made. Initially, every office had a code book and a CD. Due to waiting for sending information to the General Code, there is more of a charge now because of waiting five years. The town needs a paper copy, but mostly it will be a disk. Supervisor Spears said the cost was \$1195. Ms. Santini said this will allow posting all changes on the website. Discussion continued. Supervisor Spears then read from their communication they would provide *posting of new laws, post legislation not yet codified in between supplements, easy and flexible searching using key words or phrases, section numbers and more, download it to Word, download code text in Microsoft Word document to track changes when drafting new legislation, download to PDF, download texts and graphics to Adobe, sign up to receive notification of changes in codes, etc.* Councilman Dean asked how often people come to the office asking to see the General Code and Ms. Santini replied not often.

**Motion to Look into Codification Services by General Code for the Town of Deerpark**

Motion by Alan Schock, 2<sup>nd</sup> by Arthur Trovei to look into codification services by General Code for the Town of Deerpark.

Discussion: Councilman Trovei said he wants to know what all the hidden costs are, and what codifying resolutions and local laws cost. Supervisor Spears read the first charge is \$7,500.00 which includes updating the 2004 Code through Local Law No. 3 of 2016 and Resolution No. 6 of 2016. Councilman Schock asked if anyone else does this. Supervisor Spears and Town Clerk Santini didn't know of anyone other than them. The initial cost in 2004 was \$17,000.
