Presentations/Communications

Supervisor Spears mentioned receiving a *Certificate of Completion for the Dog Control Officer* Thomas Yonskie, of the eighth Annual DCO Conference for 12 hours of training with the New York State Department of Ag and Markets. He also reported receipt of a thank you letter from the *Human Society in honor of DCO Appreciation Week* and they thanked him for the services he provides the community as well as the welfare of the animals and it was signed by about 8 or 9 people.

Laurie Raskin, Forester of DHW Forest Consulting made her presentation in regards to the potential of conducting a timber harvest on the town's land off the Peenpack Trail and Boehmler. (A copy of her handouts is attached to the official minutes.) She referred to the non-harvestable land and the economically feasible land that may have a viable harvest where competitors might bid on or sawmills might be interested in buying. Ms. Raskin then presented a service agreement briefly for the board's consideration. She mentioned the mock prospective was just to provide a sampling to give an idea of how it would read.

Councilman Dean asked if she had a fee schedule and she said there is a 15% of the bid winner and that would cover her fees. The town wouldn't pay her, but it would come out of the bid. Discussion continued.

New Business

Supervisor Spears presented the Highway Superintendent's request for approval to purchase equipment. He prefaced it by saying he does have \$100,000 in his 2017 budget for maintaining properly for the highway equipment. They also had a totaled truck damaged in a snow storm. But, they had an 8 year old truck that they paid about \$150,000 for and were reimbursed \$203,000 for when totaled, and they got the old truck as well. Ed Hughson and Councilman Trovei worked on this. They want to purchase a 2008 Challenger Tractor Model MT455B 4WD with a 50 inch Flail Mower. The tractor came from another

Town so no bid is needed and the purchase price is \$38,000. This has a hydraulic arm mower that can reach over guardrails and into ditches that can save them labor costs. They are on a continual basis of replacing pickups and mason dumps that come with plows. He has a price for a 2017 Ford F350 pickup with a 9 foot Western snow plow in the amount of \$35,401.80\ and that is off state bid. They have a good quality sander from the truck they'll replace that they can put on this truck. Also, the board gave him approval at the last meeting to purchase a Tandem Axel truck after Ed and Councilman Trovei researched which truck was best for the town. They decided to purchase a Mack Tandem Axel truck with a Tenco stainless steel U-combo body and Tenco front plow for \$228,212.85. With the insurance money, they can still make these extra purchases and have money in the budget. A letter regarding these things mentions his appreciation to Art Trovei for his hard work and time. (Attached to the official minutes).

Supervisor Spears shared they need another discussion on a joint meeting with the City of Port Jervis on annexations. At the last Port Jervis Common Council meeting, they set a date of June 19<sup>th</sup> at 7:00 p.m. for a joint meeting with the Town of Deerpark council, at the Town of Deerpark. This meeting would be for discussion and also to set a public hearing so they could announce this to the public and get the ball rolling. Mr. Spears said they had been in contact with an engineering firm that does studies. They feel they need to do a study. At the public hearing, they feel they actually need to ask what people in both towns would like to see studied. They have an extensive list, but want to hear what the general public would like to see studied and what the pros and cons might be. Originally, the list that came up when they had a brief meeting was a traffic study, tax consequences and pros and cons for both communities, employment generated and what kind of wages, water and sewer, etc. If Port Jervis takes it over, they would want to study the police part of it. Kelly Decker was in on the meeting, so he had input also. They also wanted to look at what kind of hotel tax would be generated, which would go to the city; what kind of sales tax would be generated that would go to the county, which in turn would come back to Port and Deerpark and everybody else (as much as the same as Woodbury Commons gets shared around the county). They want to look at the school and what kind of money the taxpayers would save if they didn't have to build a new sewage treatment plant. The Middle School is already on the Port Jervis Water and Sewer and the cost is minimal. The Port Jervis High School is on city water now, they learned after more investigation. He talked with Jack Farr, the head of the DPW in Port and he thought the new

Sewer pump station on Joyland Auto Road would handle this with no problem. He thought as far as sewer treatment plant costs, which would be in the millions to build and this could be \$400,000 – \$500,000 to tap into. So, that is their list but they do want to, after the June 19<sup>th</sup> meeting they hopefully will set, the gist of it is to get to a Public Hearing so they can get everything out on the table--both from the Port Jervis Council people and from the general public. Councilman Dean said the sewer from the school versus a sewer treatment plant--if that happens, you would have two treatment plant positions on the school payroll and that is not inconsequential. Supervisor Spears said he found out that though that was the case in the past, now they are usually a professional service to provide that service to the school. So, that would come up at their joint meeting or at a public hearing to get that type of information out. There will be a proper way to do it. It won't be a fast process like they hoped it would be to get shovels in the ground, but he thinks it is the right way to do it so they stay out of court in the future. He asked the towns' counsel if he had anything to add and Town Attorney Glen Plotsky suggested that with the engineering firm doing the studies, they would also insist on a SEQRA.
