ADDENDUM TO SEPTEMBER 18, 2017 BOARD MINUTES

The comments I rise to provide address the homes on Piatt Drive, not the building on Rte 209. At the conclusion of my recitation, I will provide copies of this statement to town officials, and to any newspaper reporters who are present tonight.

There are eyewitnesses in the community willing to testify that they have seen evidence of a safe hiding area in the immediate vicinity of the two houses on Piatt Drive that appears to date to the mid 19th century or before.

As Cuddebackville is not located in an area where such safe hiding areas were needed for tax evasion on imported goods, the most likely reason for such a space is use in the Underground Railroad, as described in the 1881 account of Laura Haviland's work in the Underground Railroad, *A Woman's Life Work*". And, indeed, oral history traditions in the town assert that the hiding area may have been used for the Underground Railroad.

As demolishing these houses and doing site preparation for any subsequent use of the land will, in all likelihood, destroy material culture evidence of the feature described above, I rise to request that any decision on demolishing the houses on Piatt Drive be delayed until the following events can take place.

- 1. Interviewing and recording oral history accounts of area resident with personal knowledge of the feature.
- 2. Due diligence by trained historians and preservationists who specialize in Black History in documenting any important features in the area of the houses on Piaatt Drive.
 - a. The Town of Deer Park, County of Orange, and State of New York have historians and offices of Historic Preservation, but their professional staff may or may not be specialists in black history. However, there are others who have this expertise.
 - b. Indeed, there are a number of institutions of higher learning in reasonably close geographic proximity to Orange County that offer Black Studies, African and African American Studies, and Black History programs. In2017, Rutgers, the State University of NJ was named by US News and World Report the #1 best grad school for African American History. It would require minimal due diligence to contact these institutions to see if they have faculty or students who would be willing to take on a project of documenting
 - i. Whether or not the feature exists,
 - ii. The likelihood that it might have been used for the Underground Railroad, and
 - iii. appropriate actions to either preserve or memorialize its existence in this part of Orange County, NY.
- 3. If the feature or the houses—are found to have historic merit or importance, the town could offer them for sale to individuals or organizations willing to commit to appropriately preserving or, memorializing this potential evidence of the Underground Railroad.

We are not demanding preservation of the houses, or memorialization of the feature. We are simply asking that you delay any decision about demolishing these houses until due diligence can be done and any historic significance appropriately documented.

As women were some of the most diligent activists in the abolitionist movement, this has relevance to both women's history and black history.

We see on the news every night that Americans are rising up to demand that African American history and slave history be acknowledged. Do you want to be the town that decided at this critical moment in history to demolish these buildings without even investigating their potential importance in the history of enslaved Americans?

I hope not, and I respectfully request that any decision to demolish be delayed until and unless the board has a determination that there is no historic significance, or has made arrangements for appropriate preservation or memorialization as recommended by professional historians or preservationists.
