Presentation on E0203 NYS Police Reforms Reinvention Committee

Stu Rosenwasser of the Orange County DA's office gave the Town Board and residents a presentation on the new Police Reforms that are being handed down from the State. Mr. Rosenwasser explained to everyone what is going to be needed in the next few weeks to have everything in order to be sent to the State for review and acceptance. There will be a committee of local police, members of the public, non-profit, DA's office, non for profit, local elected officials. They will review policy and procedures for the Town of Deerpark. Meetings will be held and they will be able to ask and have questions asked. Town of Deerpark will not be the same as in other big towns and or cities. The Supervisor will appoint members to this committee. This has to be all taken into what the town will be having to do. They will make a plan with the attorney, a final plan sent to town board, supervisor and then sent to State by April 1, 2021. If not, funding can be taken away. Each and every police department has to do this.

Chief Richard Sztyndor also gave presentation on our police department, he gave the board and residents information that included number of police officers, service calls, demographic of the Town of Deerpark and our hiring and recruitment procedures.
