Al Fusco: The project that has been decided is to work on the Senior Center. We're looking to put in a vestibule outside the existing doors and have automatic openers on both sets of doors. In addition, we will install either a chlorinator or a UV system on the water system. In addition, we put into the application a generator for the entire building in case of emergencies for use by the town. There are 3 Resolutions- one is for you to accept the choice of that project, the other is to in addition to that, to put out Governing Body Fair Housing Resolution, and the last is to put out a Governing Body Authorizing Resolution. The fee that we put down for this is \$125,000, and then a \$25,000 share.

TOWN OF DEERPARK, ORANGE COUNTY, NEW YORK LOCAL LAW NO. 2 OF 2021 A LOCAL LAW REPLACING CHAPTER 67 OF THE TOWN OF DEERPARK CODE AND RE-ESTABLISHING THE TOWN POLICE COMMISSION

ARTICLE I. Board of Police Commissioners

§ 67-1. Repeal of Prior Law.

The Town Board of the Town of Deerpark hereby repeals what was previously Chapter 67 of the Town of Town of Deerpark Code and creates a new Chapter 67 with this Local Law.

§ 67-2. Legislative Intent.

By the adoption of this Article, the Town Board of the Town of Deerpark has elected to establish a Board of Police Commissioners pursuant to §150, Subdivision 2, of the Town Law of the State of New York and §22 of the Home Rule Law of the State of New York.

§ 67.3. Definitions.

The words and phrases and definitions of words as used in the New York State Town Law shall be applied in the enforcement of the Article.

§ 67.4. Appointment of Commissioners.

The Town Board of the Town of Deerpark does hereby establish a Board of Police Commissioners for the Town. The Police Commissioners shall be appointed by the Town Board. The Board shall consist of Five (5) Commissioners who shall, at the time of their appointment and throughout the term of their office, be electors of the town, and who shall serve without compensation, and at the pleasure of the Town Board. No more than One (1) of the Police Commissioners shall be a Town Board member from the Town Board of the Town of Deerpark. In the event that no Commissioner shall be a Town Board member, there shall be designated by the Town Supervisor, a liaison between the Town Board and the Board of Police Commissioners.

§ 67.5. Appointment of Alternate Commissioners.

The Town Board may appoint no more that Three (3) Individuals to serve as alternates for the Board of Police Commissioners. Alternate members, shall, at the time of their appointment and throughout the term of their office, be electors of the town, and who shall serve without

compensation, and at the pleasure of the Town Board. An Alternate may only become a voting member of the Board of Police Commissioners if a Commissioner is absent or abstains and such absence or abstention results in a failure to satisfy quorum requirements.

§ 67.6. Powers of the Board of Police Commissioners.

The Board of Police Commissioners shall have and exercise only powers relative to police matters conferred upon them by the Town Board of the Town of Deerpark and as may be authorized pursuant to Article 10 of the Town Law of the State of New York. These powers may include review of all police operations, review of all citizen complaints, review of all departmental complaints, making recommendations to the Town Board for action and any additional duties as may be delegated to the Board of Commissioners by the Town Board of the Town of Deerpark and as otherwise are not inconsistent with the laws of the State of New York. This article has been created and enacted in order to specifically supersede any prior resolutions or Local Laws adopted by the Town Board establishing or abolishing a Board of Police Commissioners within the Town of Deerpark.

§ 67.7. Chairperson of the Board of Police Commissioners.

The Chairperson of the Board of Police Commissioners shall be appointed by the Town Board of the Town of Deerpark. The Chairperson shall hold that position at the pleasure of the Town Board of the Town of Deerpark.

ARTICLE II. Background Checks for Candidates.

§ 67.8. Title.

This Article shall be entitled "Investigation and Fingerprinting of Police Commissioner/Police Chief Candidates in the Town of Deerpark, Orange County, New York."

§ 67.9. Intent; Authority.

The Code that follows deals with the establishment of fingerprinting and background checks for all candidates for appointment to the Office of the Town Police Commissioner/Town Police Chief with the Town of Deerpark. By adoption of this Article, the Town of Deerpark declares its intent to fingerprint and perform background checks on all future candidates for appointment to the Office of Town Police Commissioner/Town Police Chief. Authority for the Article comes from the provisions of §25-a of the New York State Town Law.

§ 67.10. Definitions.

- A. As used in this Article, the following terms shall have the meanings indicated:
 - 1. TOWN POLICE CHIEF and TOWN POLICE COMMISSIONER and APPOINTEE TO THE OFFICE OF TOWN POLICE COMMISSIONER OR APPOINTEE TO THE OFFICE OF TOWN POLICE CHIEF Any person appointed by the Town Board of the Town of Deerpark to fill the position of member of the Deerpark Police Commission or Department Head of the Police Department of the Town of Deerpark.
- B. The words and phrases and definitions of words as used in the New York State Town Law shall be applied in the enforcement of this Article.

§ 67.11. Fingerprinting and Background Checks.

- A. Each candidate for appointment or appointee for the Office of Town Police
 Commissioner or Town Police Chief in the Town of Deerpark shall have a fingerprint
 impression of the fingers and thumbs of both hands taken by the Police Department of the
 Town of Deerpark. The Police Department of the Town of Deerpark is authorized to
 forward the appointee's fingerprints to the New York State Division of Criminal Justice
 Services for a criminal investigation prior to the Deerpark Town Board's confirmation of
 said candidate's appointment as Town Police Commissioner or Town Police Chief. The
 Deerpark Town Board shall be responsible for paying the required fee for said
 background investigation in the form of a check or money order made payable to the
 New York State Division of Criminal Justice Services, and shall forward said payment,
 together with the fingerprints, to the New York State Division of Criminal Justice
 Services. The Town Board of the Town of Deerpark shall review the information secured
 as a result of said investigation and shall keep any such information confidential.
- B. The Town Board shall not confirm the appointment of any candidate who has been convicted of a Felony or Class A Misdemeanor as defined int the Penal Law of the State of New York, and who has not, subsequent to such conviction, and prior to application for such position, had this disability removed as provided in the New York State Correction Law §751. An application for an exemption to this requirement for an appointee convicted of a Class A Misdemeanor may be made to the Town Board, and upon good cause shown, the Town Board may waive this disability.

ARTICLE III. Supervision of Dog Control/Animal Control Officers.

§ 67.12. Legislative Intent.

By the adoption of this Article, the Town of Deerpark declares its intent to include within the definitions contained herein, the position of Dog Control Officer/Animal Control Officer.

review of all operations, review of all citizen complaints, review of all departmental complaints, making recommendations to the Town Board for action and any additional duties as may be delegated to the Board of Commissioners by the Town Board of the Town of Deerpark and as otherwise are not inconsistent with the laws of the State of New York relative to the position of Dog Control Officer/Animal Control Officer. It is specifically the intent of the Town of Deerpark to reserve to the Town Board the power to hire or fire all persons employed in the said capacity as Dog Control Officer/Animal Control Officer.

§ 67.13. Definitions.

The words and phrases and definitions of words as used in the New York State Town Law and/or the New York State Agriculture and Markets Law shall be applied int the enforcement of the Article.

§ 67.14. Authority Retained by Town Board.

The position of Dog Control Officer/Animal Control Officer, having been previously created by the Town of Deerpark, the Town Board of and for the Town of Deerpark hereby retains all authority to create or remove such position of employment, as well as the authority to appoint, hire, fire, contract for services with, and/or otherwise establish and maintain the position of Dog Control Officer/Animal Control Officer.

§ 67.15. Authority Delegated to Police Commissioners.

The Town of Deerpark hereby expressly delegates the authority to verify the hours of employment/work performed, and to monitor reports and other documentary information generated as a result of the said employment of persons employed by the Town of Deerpark in the position of Dog Control Officer/Animal Control Officer. After review of said documentation by the Police Commission, it shall be the responsibility of the said Commission to file copies of all such records with the Office of the Town Clerk of and for the Town of Deerpark where said documentation shall be maintained as an official Town record.

Governing Body Fair Housing Resolution

The Town of Deerpark supports Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New York State Human Rights Law. It is the policy of Town of Deerpark to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex (including pregnancy), national origin, nationality, familial status, martial or domestic partnership status, affectional or sexual orientation, atypical hereditary cellular or blood trait, genetic information, liability for military service, mental or physical disability, perceived disability, AIDS/HIV status and Lawful Income or Source of Lawful Rent Payment (Section 8). The Town of Deerpark further objects to discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability as prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New York State Human Rights Law. Therefore, the Municipal Council of Town of Deerpark do hereby approve the following resolution.

BE IT RESOLVED, that within available resources, the Town of Deerpark will assist all persons who feel they have been discriminated against under one of the aforementioned categories, to seek equity under federal and state laws by filing a complaint with the New York State Human Rights Law and the U.S. Department of Housing and Urban Development, as appropriate.

BE IT FURTHER RESOLVED, that the Town of Deerpark shall publicize this resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law, the New York State Human Rights Law, and any local laws or ordinances.

BE IT FURTHER RESOLVED, that the municipality will at a minimum include, but not be limited to: (1) the printing and publicizing of this resolution, a fair housing public notice and other applicable fair housing information through local media, community contacts and placement on the Municipal website and in other social media; (2) distribution of posters, flyers, and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing.
