Statement from the Supervisor- 1

Myself and the Town Board have received an Ethics Complaint. The complaint has been turned over to the Orange County Board of Ethics. This has been done to ensure that the process has no bias towards either party.

The Town Board will wait on their decision, recommendations or any actions that they provide to the Town of Deerpark.

We will not be addressing any discussion on the current Ethics Law at tonight's meeting as the complaint was filed under that law still in effect.

When we receive the final determination from the Orange County Board of Ethics, we will reopen the Ethics discussion.

Statement from the Supervisor-2

We have now been informed that the complaint that was filed was fraudulent. It was signed as being submitted by the Deerpark Rual Alliance fraudulently, as it was not.

On Saturday I received an email from Grace Woodward of the Deerpark Rual Alliance which I shall read followed by my reply to her.

This morning, I notified the Orange County Board of Ethics through their Secretary, addressed to the Chairman of this new information.

Tomorrow I will notify the Orange County District Attorney, the NYS Comptroller and the NYS Attorney General of this fraud. I will ask for an investigation into the person or persons who committed it.

September 2024 monthly report

During one of my monthly reports, I mentioned I applied for an Orange County Legislature grant through our Legislator Tom Faggione. I'm happy to report we received the grant which totaled \$4835.14. The money was used for (10) new garbage can lid and (6) new picnic tables from Greys Woodworks. The picnic tables have been stained and will go under the pavilion at HSP. In addition, I ordered (6) more to replace the dilapidated tables at the Sparrowbush Park.

The water system at the barn has been completed by the contractor. On recent hire James Wilson is a 2b NYS certified water operator so we can handle the testing in house.

Shoulders have been installed on all the roads we paved. We also added some black top ditches on Peenpack where erosion has been an issue in the past. This should help maintain the integrity of our shoulders and direct the water into the culverts.

We did some landscaping around town hall in preparation for the 911 ceremony along with set up and tear down.

Additional street signs were replaced which the updated version. This will continue as time permits.

The price as asphalt dropped for the month of October by over \$3 a ton so we are paving a few smaller roads ourselves. We completed all the infrastructure work on Paradise Road and paving began last week. I'll update you on the progress in November's report.

We hand (2) emergency situations which resulted in call ins for the month.

We also assisted the PD with set up and tear down for traffic control at the Moon Festival.

I am still actively looking for a replacement for our aged out tandem/wing. I began to bid on a 2020 Freightliner on Thursday but the municipality selling it extended the auction 15 more days due to a cancelled town board meeting. The auction ends on 10/17 so I intend to bid on that date.

I also received pricing for loaders to replace our 1993 JD. Once the board feels we have funding, we can discuss the matter further.
