November 2024 Monthly Report

Harriet Space Park, the Grange, and the Museum were all winterized.

Leaves were picked up on town roads with a focus on gutters where frozen leaves prevent property water flow

Our entire fleet was outfitted with its winter gear; plows, sanders, etc

We repaired a large retaining wall on Brandt Road

Prior to the asphalt plant closing, we paved potholes throughout the town with hot mix

We used the hammer attachment we purchased earlier in the spring and created a small culd-e-sac on Cuddeback Road. Prior to this, we relied on a private driveway to turn our plow trucks around in since the road is a dead end. This not only makes it easier for our operators but reduces any liability of damaging private property.

The new picnic tables for the Sparrowbush Park have arrived. Each was stained and placed under the pavilion for use.

On 11/22, our area received its first snowfall. Totals varied drastically from one end of town to the other. All members were called in at 2am and we worked the duration of the storm.

Thanksgiving morning, I had to call guys in to handle a couple inches of snow in our upper elevations.

We're still cleaning down limbs and trees from the storm. Most of the town is finished with the exception of the Neversink Drive corridor.

We excavated the old tennis courts and basketball courts in HSP In preparation for the new pavilion. I am meeting with John Fuller and the foreman from (building contractor) ATEC tomorrow morning to lay out the footings which we will begin digging shortly thereafter. I'd like to thank Art Trovei for offering and donating an excavator to expedite the digging process. This will cut the digging time by at least 1/3

I'd like to wish everyone a safe and happy holiday season and we'll see you all in the beginning of January for my December report which will include by 284 agreement.
