WHEREAS, the Town Board has been advised that the Orange County District Attorney's Office has commenced an investigation into potential criminal behavior by said employee; and

WHEREAS, the Chief of Police, Deputy Chief of Police, and Senior Staff at the Orange County District Attorney's Office have expressed concerns regarding the viability and prosecution of any matters in which the said employee has been or may be involved in the future.


