September 2025 Monthly Report

For the month, members were called in (2) times for a trees being down blocking the roadway.

All crossover pipes on Galley Hill have been paved. A couple new catch basins have been installed in problematic areas to keep water off the road surface. I spoke with Ward paving today and have a tentative date of October 27th and 28th for paving.

We assisted the town clerk with setting up and tearing down for the 911 ceremony.

UDC clean up along the Hawks Nest was completed and it was billed out.

Mowing of the town parks continues on a weekly to bi-weekly basis depending on conditions.

Mowing of roadway edges is just about wrapping up. We started the month in the Westbrookville area working our way down to Port Jervis. We'll be finishing in the Rio area soon.

We removed some problematic trees at the top of Big Pond Road. There were several trees there that were dead.

Fog sealing was completed on all the chip sealed road. I'm happy to report Suit Kote did an excellent job and we've received quite a few compliments from residents.

We've began preparing Greenville Tpke for surface treatment next year. This is an important step toward a more frugal approach since the material used for leveling the roadway will have time to dry and will not need a fog seal prior to surface treatment.

Both working leaders attended a snow and ice control class hosted by the Ulster County Highway Superintendents Assoc. and put on by the Cornell LTAP center. Both gained knowledge which can be passed on to other truck operators during in service training.

Lastly, I attended the Fall NYSAOT Fall conference for Highway Superintendents where I attended the re-organizational meeting for the state association.
