RESOLUTION #14 of 2025
TO ACCEPT A GIFT CONSTITUTING REIMBURSEMENT
FOR PAVING AND RELATED COSTS FOR THE IMPROVEMENT OF
GALLEY HILL ROAD IN THE TOWN OF DEERPARK
FROM DRAGON SPRINGS BUDDHIST, INC.

WHEREAS, the Town Board of the Town of Deer Park, County of Orange, State of New York has the obligation to maintain and improve public roads in the Town of Deer Park, County of Orange, State of New York; and

WHEREAS, Galley Hill Road is a public road located in the Town of Deer Park, County of Orange, State of New York; and

WHEREAS, Dragon Springs Buddhist, Inc. is a tax exempt entity whose property is located at 140 Galley Hill Road and one side of which borders on Galley Hill Road in the Town of Deer Park, County of Orange, State of New York; and

WHEREAS, Dragon Springs Buddhist, Inc. has offered to pay for the cost of repaving and improving Galley Hill Road in order to contribute to and assist residents of the Town of Deer Park who reside in the vicinity, and who therefore may be impacted by, their facility; and

WHEREAS, the Town of Deer Park Highway Department contracted out for the repaving and improvement of the public road, known as Galley Hill Road in the Town of Deer Park, County of

Orange, State of New York, from 140 Galley Hill Road to the intersection with New York State Route 211 with the work being performed by Ward Paving in conjunction with the Town of Deerpark Highway Department on November 3, 2025 and November 4, 2025; and

WHEREAS, the cost of the said repaving/improvement of that section of Galley Hill Road in the Town of Deerpark was Two Hundred Thirteen Thousand Nine Hundred Nineteen and 58/100 Dollars (\$213,919.58); and

WHEREAS, Dragon Springs Buddhist, Inc. has tendered a check in the amount of Two Hundred Thirteen Thousand Nine Hundred Nineteen and 58/100 Dollars (\$213,919.58) as a gift representing the cost of the repaving and improvement of Galley Hill Road.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

RESOLVED, by the Town Board of the Town of Deerpark, Orange County, New York, that the Town Board of the Town of Deerpark hereby does approve the acceptance of the gift from Dragon Springs Buddhist, Inc. in the amount of Two Hundred Thirteen Thousand Nine Hundred Nineteen and 58/100 Dollars (\$213,919.58) representing the cost of repaving and improving Galley Hill Road as set forth above; and be it further

RESOLVED, by the Town Board of the Town of Deerpark, Orange County, New York, that the Town Supervisor of the Town of Deerpark is hereby authorized to accept the gift from Dragon Springs


