RESOLUTION 2 of 2026

AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONEYS

AGREEMENT between the Town Superintendent of the Town of Deer Park, ,Orange County, New York, and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repair and improvement of highways, and received from the State for State Aid for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS. The sum of \$ 459,500.00 shall be set aside to be expended for primary work and general repairs upon 3.4 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.
2. PERMANENT IMPROVEMENTS. The following sums shall be set aside to be expended for the permanent improvement of town highways:
 - (a) On the road commencing at Schoolhouse Rd., Black Rock Trail, and Painted Aprons Terrace and leading to Painted Apron subdivision, a distance of 0.89 miles, there shall be expended not over the sum of \$ 110,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
 - (b) On the road commencing at Zock Rd. and leading to dead end, a distance of 0.66 miles, there shall be expended not over the sum of \$60,000.
Type: Asphalt Width of traveled surface: 12'
Thickness: 2"
 - (c) On the road commencing at Third St. and leading to Avenue C, a distance of 0.39 miles, there shall be expended not over the sum of \$ 30,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
 - (d) On the road commencing at Georgian Terrace and leading to dead end, a distance of 0.13 miles, there shall be expended not over the sum of \$ 20,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"

- (e) On the road commencing at Grange Rd.
and leading to Peenpack Trail, a distance of 0.3 miles,
there shall be expended not over the sum of \$40,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
- (f) On the road commencing at Hagen Rd.
and leading to NY Rte 42, a distance of 0.23 miles,
there shall be expended not over the sum of \$ 25,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
- (g) On the road commencing at Griffin Rd.
and leading to Town line, a distance of 0.15 miles,
there shall be expended not over the sum of \$ 22,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
- (h) On the road commencing at Horseshoe Bend Rd.
and leading to Town line, a distance of 0.65 miles,
there shall be expended not over the sum of \$ 60,000.
Type: Asphalt Width of traveled surface: 18'
Thickness: 2"
- (i) On the road commencing at Plank Rd.
and leading to Town line, a distance of 1.25 miles,
there shall be expended not over the sum of \$ 55,000.
Type: Chip Seal/ Fog Seal Width of traveled surface: 18'
Thickness: N/A
- (j) On the road commencing at Greenville Tpk.
and leading to Town line, a distance of 1.18 miles,
there shall be expended not over the sum of \$ 37,500.
Type: Chip Seal/ Fog Seal Width of traveled surface: 20'
Thickness: N/A

3. All of the foregoing is my best estimate of what I will do in 2026. However, all of this is based upon the information I have at this time. If the funding I expect is reduced; materials and labor are unavailable or increase in cost; or if emergencies arise, all of my intended work may/will change based upon circumstances.
