Michael Sullivan-10 Maple Lane- Mr. Sullivan stated he has lived there for 48 years and that the Traynor's neighbor; Mr. Beatini is very upset with this shed and has photos showing how close to the line it is. He also stated that Mr. Beatini told Mr. Traynor when the shed was being put up that it could not go there. Mr. Sullivan asked to show the photos, Bob Zeller acknowledged that the Board already received them. Mr. Sullivan continued that it is a fire hazard and an eye sore and a lot of people are upset with this. Bob Zeller stated that there was written comment regarding this application. Mr. Sullivan stated that there are other sheds in the neighborhood but they are in the backyard.

Justin Traynor-Applicant- Mr. Traynor acknowledged on the day the shed was delivered, Mr. Beatini stated that it was too close to the property line and he told Mr. Beatini he called that Building Department and that they did not need a permit for the shed but didn't know the shed had to be setback from the line. Bob Zeller asked if there was any other location that the shed could be placed. Mr. Traynor replied that there is a dilapidated shed in the backyard but the septic tank and leach field is in the backyard and they could not use a machine to move it and it would probably not be 10ft from the line either. Bob Zeller asked if there was any other alternative, Mr. Traynor answered he could move it to the other side but would still need a variance but definitely not in the backyard. Mr. Traynor asked to hold over to the January meeting, he further stated that whatever happens he will abide, he was not aware of the setbacks.
